WHY CANADA?

- Canada is an ideal 1st market for new-to-export companies and those seeking to expand their business and distribution networks. Canadian partners are most interested in innovation and products that provide time, labor and/or cost savings.
 Being a mature market, "me too'/commodity products focused solely on price, may find market entry challenging, as competitive products are well-established. Successful companies must clearly articulate their value proposition to the market and potential customers and partners.
- Canada is Pennsylvania's No. 1 export destination, and PA sells more goods to Canada than to Mexico, China, and Japan combined
- Pennsylvania exported \$10.8 billion USD worth of goods to Canada in 2018, a 5% increase
- U.S./Canada trading relationship is the largest in the world, trading more than \$2 billion in goods and services daily

Toronto (Greater Toronto Area/GTA), Ontario is Canada's most populous city at 6.2 million (2018). **It is North America's 4th largest metro area.** 1/4 of Canada's population live within a 100-mile (160-km) radius of Toronto. Industries such as financial services, life sciences, ICT, advanced manufacturing, aerospace, automotive and agri-food are all found in the "Golden Triangle" surrounding the GTA.

Montreal, Quebec is Canada's 2nd largest city with 4.1 million people. Montreal is one of the world's top 5 video game production cities alongside Tokyo, London, San Francisco and Austin. The city excels in the field of artificial intelligence and attracts many university students, researchers and investment for the sector.
