We are pleased to announce that Greater Philadelphia is one of eight metro areas selected to participate in the Global Cities Initiative's Exchange, a five-year joint project of the Brookings Institution and JPMorgan Chase to promote sustainable economic growth, first addressing exports and then foreign direct investment. The Region will begin by developing a metropolitan export plan in 2015.

The World Trade Center of Greater Philadelphia and the Economy League of Greater Philadelphia are spearheading the effort which will bring together public and private sector leaders, including global corporations and exporting firms to develop an export strategy over the next twelve months.
